The subject of precision and semi-precision attachments can be confusing and frustrating. Attachment dentistry provides superior cosmetic and functional alternatives to the traditional cast partial denture with clasps. Attachments are simply rigid or resilient connectors that redirect the forces of occlusion. They are stress attenuators and absorbers. Their function is to preserve soft tissue and bone, as well as provide retention, correction of angular discrepancies, and cosmetic alternatives. This full-day program emphasizes the rationale for using precision and semi-precision attachments in the treatment planning of fixed and removable partial dentures, over-dentures, and implants. 

Minimally-invasive, Image-guided Endodontics and Endo/Restorative

Clinical technique for addressing the Endodontic Triad for Success has focused on the shaping of canals, cleaning in three dimensions, and filling root canal systems as a means of maximizing bacterial reduction or elimination and prevention of apical periodontitis. Traditional dogma, the associated legacy concepts, technique end-points and attendant predictors and measures of outcome have misdirected the specialty of endodontics for decades. The current models of endodontic treatment do not lead to long-term success and may actually compromise it. A new framework for decision-making that is based on a modern understanding of the biology and disease vs. disease-that-matters will be introduced. Image-guided treatment enhanced with CBCT allows far more precise and conservative titration of treatment. We use both projection radiograph and CBCT to help determine the need for treatment, plan endodontic access, guide canal location and assess treatment efficacy. Using CBCT, innovative treatment protocols that reflect the modern understanding of endodontic microbiology and the importance of anatomic and structural limitations will be developed in a case-based format. Alternative treatment protocols using modern materials, instruments, and techniques that reflect this new understanding will also be developed.

- 1) How to use imaging to identify key zones of mutual interest and plan endodontic access.
- 2) How to precisely locate relevant anatomy while preserving key cervical tooth structure.

The participants in this course will work on typodont models that will have implants placed in them. Two attachment abutment systems are used for demonstration. An attachment abutment is placed on the implant and torqued to the required torsion as directed by the specific implant abutment requirements. The process of how the male or female attachment is picked up in cold cure acrylic is demonstrated for each of the attachments' abutment systems. The procedure is repeated for the other attachment abutments. The corresponding male or female retentive element located in the denture is checked for retention on the model. This element is then changed and a new one is replaced, thus simulating what is done chairside by the dentist. The workshop will include the use of appropriate block-out materials. A hands-on approach is used throughout the session, as well as a PowerPoint presentation for demonstration purposes. By the conclusion of the session, participants will experience increased confidence to include attachments in their treatment planning and have a greater level of confidence when placing attachments chairside.

Cone beam computed tomography (CBCT) is exploding in dentistry, leaving clinicians wondering how to not just interpret this new imaging modality, but how to go about the interpretation of imaging studies. Where do I start? How can I not miss things? What are the differences between CBCT and projection radiography? The expectation of performing the interpretation task based on mental models of PA and BW projection radiographic is a setup for problems. In other words, what you see is not



what you get, especially for us. The problems start with the underlying physics, are carried through the image reconstruction process, and are amplified with the occult biases present in both perception and cognition brought to the image interpretation task. As important as understanding the technical issues with CBCT reconstruction is, the perceptual and cognitive issues are even more important.
